Donation Update

Twenty-two Acacia alumni made donations in 2008. These donations totaled \$3,368 towards the re-colonization effort and another \$1,050 in voluntary alumni dues. They have also pledged a total of \$4,747 for 2009 and 2010. The money donated to the Acacia Fraternity Foundation (AFF) University of Iowa Chapter Fund is tax deductible and will be used to provide scholarships to Acacia Graduate Students that will help oversee the reformation of the Iowa

Chapter of Acacia. The \$75 Annual Voluntary dues are used to help pay for the mailing cost of The RESH newsletter and are also used to help offset the costs of social events. Facility Update

Spring is less than a month away, so it is time to start thinking about improving the property at 202 Ellis Ave. Last year we accomplished several big projects and a few smaller unplanned projects.

In the summer of 2008 our tenants, Pi Kappa Phi, took some initiative and refinished the hardwood floor in the chapter room. We all knew this needed to be done and they did a great job at a fraction of the cost of a contractor. Also, during the summer and fall we hired James Rensberger again to come in and shore up the exterior of the house. James repainted the stucco around the front entrance, replaced the rear wooden stairs, and gave the corner fascia a "fascia lift." Also the front stairs were replaced to try and stop all the cracking and heaving.

For the summer of 2009 we have just as many projects planned. Currently we are taking bids for tuck pointing the

two chimneys and that project will hopefully be completed in the early summer. We will also be updating some of the electrical throughout the house. All of the electrical needs to be updated, and the corporation board has decided to do it in phases to try and make the bills a little more palatable. One special project that is being considered is a full size deck off the northeast rear corner of the house. PKP's national philanthropy is building wooden ramps/decks/entrances for handicapped individuals, so several members have experience with this type of work. The details still have to be finalized, but hopefully the deck will be complete for the start of the 2009-2010 school year.

Just wanted to let you know that I got my first legal job. It is with GE Medical. GE Medical hired Legal Placement Services to find 20 attorneys for a 6 month to 1 year project. The job involves working with the other 20 junior attorneys and 4 senior attorney to sort out GE Medical's documents. When they sell a piece of medical equipment, they tell the customer, such as a hospital, "here is our contract." The hospital says "here is our purchase agreement." So GE Medical doesn't know which of the two documents is signed or which one is binding or whether there is an arbitration clause. The two weeks of training starts on Monday, Oct. 27th, and the project will start on either Nov. 10th or 17th. The project will easily last 6 months and has a good chance of taking a full year.
